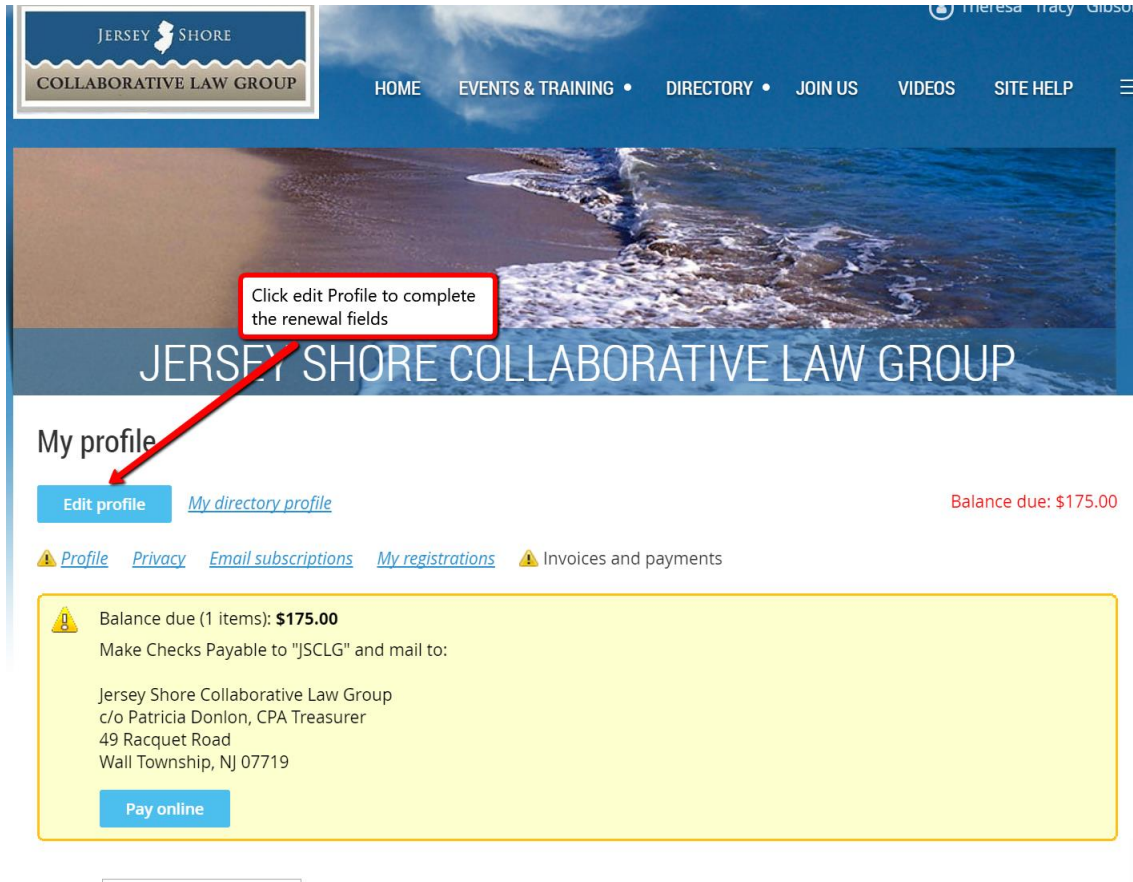


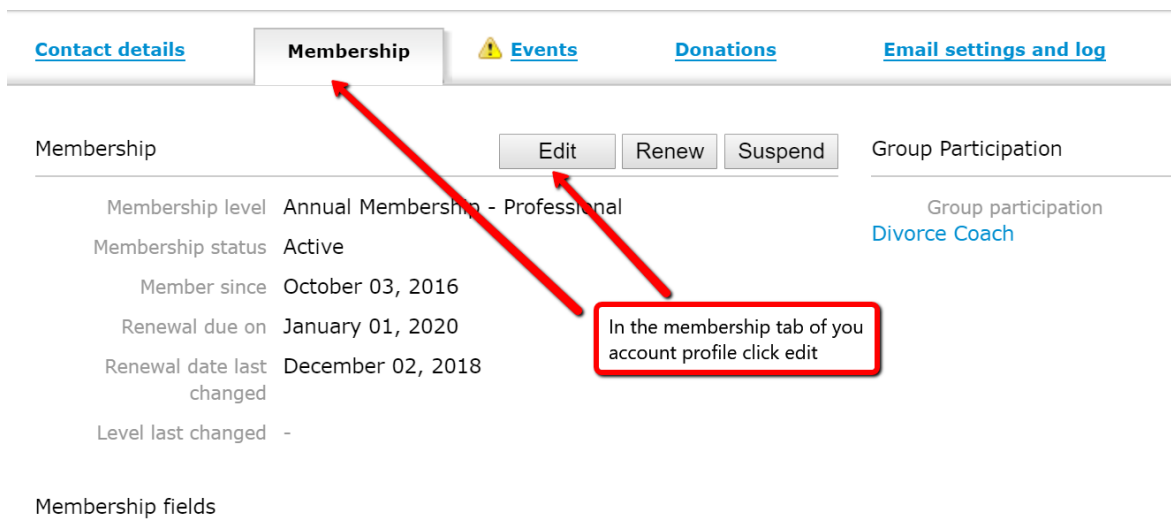
# JSCLG – How to Renew Your Membership
